This Release includes any employee and/or agent instructing under Releasee's supervision or direction during classes.

In view of the foregoing, and as a term and condition of being a student of the Releasee, Releasor, with the intention of binding himself or herself, his or her spouse, heirs, legal representatives, and assigns, expressly Releases and discharges Releasee and heirs and legal representatives from all claims, demands, actions, judgments, and executions that Releasor ever had, or now has, or may have, or that anyone claiming through or under him or her may have, or claim to have, against Releasee or heirs or legal representatives, created by, or arising out of, any and all class activity regardless of where held or when held.

This Release is for the entire premises, including but not limited to locker rooms, parking areas, sidewalks, buildings and grounds. Releasor assumes any and all risks associated with the activities he or she will undertake at or with Releasee. To the extent that section 5-326 of the General Obligations law does not apply, this Release is also for negligence on the part of Releasee.

If any portion of this Release from liability shall be deemed by a court of competent jurisdiction to be invalid, then the remainder of this Release from liability shall remain in full force and effect.
